PRESIDENT'S MESSAGE

Making ASHRAE Stronger

With only two meetings remaining before we break for the summer I find myself asking is ASHRAE stronger today than a year ago. There are many facets to that question. From a society standpoint, I would say certainly yes. ASHRAE at the society level has taken a more proactive position on updating energy standards and standards for sustainable building design. Additionally, ASHRAE will soon start to offer a number of certifications for qualified members. The first to be developed is a certification for Health Care HVAC design and others will follow soon. These are programs that will give ASHRAE a leadership role in the industry and make it stronger. From a local level there are concerns. Our local chapter membership is approximately 200 members, however our average meeting attendance is about 27 members. The average attendance has been on a steady decline for the past 6 to 7 years. In an attempt to reverse this trend we have changed many of the meetings to lunch meetings. Many of our members voiced that lunch meetings would fit their busy schedule better and for a while attendance did indeed increase. However, it seems we are now backsliding and the attendance is again down. Over the past years I believe that the programs for the most part have been outstanding and don't think that program quality is at faulty. If you disagree or have comments on that we are always open to suggestions. The point here is that the strength of our local chapter is largely measured by our member involvement and attendance at our meetings. To make our local chapter stronger and to keep up to date on the changes happening in ASHRAE, I would encourage and challenge you to get involved and attend the monthly meetings.

HVAC System Inspection, Maintenance Standard Open for Public Comment

ATLANTA - A proposed standard setting requirements for inspection and maintenance of HVAC systems is open for public comment.

ASHRAE/ACCA Standard 180P, Standard Practice for Inspection and Maintenance of Commercial Building HVAC Systems, would establish minimum HVAC inspection and maintenance requirements that aid a system's ability to achieve acceptable thermal comfort, energy efficiency and indoor air quality in commercial buildings.

The standard is being developed by the American Society of Heating, Refrigerating and Air-Conditioning Engineers (ASHRAE) and the Air Conditioning Contractors of America (ACCA). It is open for public review until April 30.

"The comments we received during the first review were almost universally supportive and constructive," Robert Baker, chair of the Standard 180 committee said. "There were several excellent comments that helped us to clarify and re-word some areas to avoid confusion. Most of these revisions were minor and could have been considered 'editorial' in nature. The committee, however, preferred to be conservative so voted to submit the entire document for public review again."

A more significant set of comments was directed to Section 5 which described mandatory inspection and maintenance items, he said. Although the suggestions for text revision were minor in nature, the layout of the section was seen as difficult and potentially confusing to use.

As a result, the committee created 25 separate tables, each of which deals with a specific type of system component. In addition several comments observed that the proposed 563 optional inspection points were better reserved for inclusion in a future guidance document as they detracted from the clarity and impact of the standard. The committee concurred and removed these, according to Baker.


